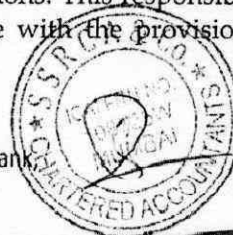
Basis for Opinion

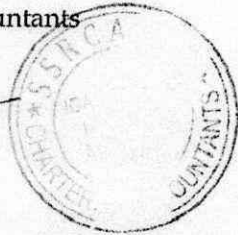
Other Matter
